## **Eligible Applicants**

 State, local, and tribal governments, transit agencies, MPOs, and other public entities

#### **Eligible Projects**

#### Cost Share or Match

- BUILD funds may cover up to 80 percent of projects costs in urban areas and 100 percent of project costs in rural areas
- Rural Designation population of 200,00 or less

#### Minimum Award

- \$5 million for projects in urban areas
- \$1 million for projects in rural areas

#### **Maximum Award**

 No more than \$25 million per project; no more than \$90 million per state



# Eligible Applicants

- State Government(s)
- Local Government(s)
- Metropolitan Planning Organizations with 200,000 population
- Political subdivision(s) of State or local government
- Public authorities (including port authorities) with a transportation function
- Federal land management agencies applying jointly with a State(s)
- Tribal government/consortiums
- Multi-state or multi-jurisdictional group of public entities



# **Eligible Projects**

- Road or bridge projects eligible under title 23, United States Code
- Public transportation projects under chapter 53 of title 49, United States
   Code
- Passenger and freight rail transportation projects
- Port infrastructure investments (including inland port infrastructure and land ports of entry)
- Intermodal projects



#### **Construction Activities**

- i. new construction
- ii. reconstruction
- iii. rehabilitation
- iv. property or equipment acquisition
- v. environmental mitigation
- vi. construction contingencies, and
- vii. operational improvements

#### **Project Development Activities**

- i. planning
- ii. feasibility analysis
- iii. revenue forecasting
- iv. environmental analysis and review
- v. preliminary engineering
- vi. design work, and
- vii. other pre-construction activities

Application – <u>www.Grants.gov</u>

- BUILD NOFO released: No later than Friday, April 19, 2019
- BUILD Grant Application Deadline: Not later than Thursday, July 18, 2019
- BUILD Grant Awards Announced: Not later than November 15, 2019

Prioritize Prepare Present Promote





## **P**rioritize

- Project aligns well against merit selection criteria
- Project's public benefits exceed the costs
- Strong support/partnership (public and private support)
- Strong cost share/matching funds (federal and non-federal)
- Project considers obligation/expenditure deadlines





# Prepare - Grant Application Format

- Project Narrative
  - Project Description
  - Project Location
  - Project Parties
  - Grant Funds, Sources, and Uses
  - Merit Selection Criteria
  - Project Readiness
- Appendices
  - Benefit Cost Analysis
  - Letters of Support/Funding Commitments
  - Supplemental Information (if applicable)

# Prepare - Benefit Cost Analysis

- Useful life of Infrastructure (20 30 years)
- Cost and Start of Operation & Maintenance
- Need for Baseline and Projected Traffic Counts (Levels of Service, Land Use Master Plan)
- Project Area Crash History (Number and Severity)
- Traffic Simulation Modeling (Benefits/Costs)
  - Greenhouse Gas Emissions
  - Travel Time
  - Vehicle Operations
  - Fuel Consumption
  - Crash/Injury
  - Property Damage

# Prepare - Environmental Readiness

- Assess
  - Historic Properties
  - Wetlands/Floodplain
  - Endangered Species
  - Sole Source Aquifers
  - Hazardous Waste Sites
  - Socio-Economic Impact
  - Others
- Determine Project Scope
  - Categorical Exclusion (CE) (0-30 days)
  - Environmental Assessment (EA) (60-120 days)
  - Environmental Impact Statement (EIS) (120-360 days)
- Public Notice/Participation

# Prepare - What Else Should I Consider?

- Secure Right of Way
- Railroad Support
- Economic Development Metrics
  - Number and Types of Jobs Created
  - Capital Investment
- Environmental Permits

Applications must be submitted via <a href="www.Grants.gov">www.Grants.gov</a>

- Obtain a Data Universal Numbering System (DUNS) number
- Register with the System for Award Management (SAM) at <u>www.SAM.gov</u>
- Create a Grants.gov username and password
- The E-Business Point of Contact (POC) at the applicant's organization must respond to the registration email from Grants.gov and login at Grants.gov to authorize the applicant as the Authorized Organization Representative (AOR). Please note that there can be more than one AOR for an organization.

Project/s should be socialized to US DOT and Congressional delegation

## **BUILD Award Process**

- BUILD 2019 Announcements (no later than November 15, 2019)
- BUILD 2019 Project Assignments (FHWA, FTA, MARAD, FRA)
- Negotiations Initiated
- Sign/Execute Grant Agreement
- Reporting Requirements/Project Modifications
- Project Completion/Close-Out
- Performance Monitoring
