FY 2019 Innovations in Community-Based Crime Reduction (CBCR) Program

The CBCR program, formerly known as the Byrne Criminal Justice Innovation (BCJI) Program, focuses on high crime communities with concentrated distress and hot spots of crime and directly supports the Department's priorities to reduce violent crime (sometimes associated with gang activity), assist communities struggling with drug abuse, and support law enforcement officers by integrating officers and enforcement strategies into community-based crime reduction efforts. Eligible applicants are limited to institutions of higher education, units of local government, national nonprofit organizations, and federally recognized Indian tribal governments.

Eligible applicants are limited to state, local, and tribal law enforcement agencies, as well as governmental non-law enforcement agencies, and federally recognized Indian tribal governments.


